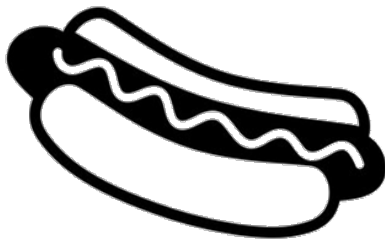




# 1<sup>st</sup> Annual HOT DOG EATING CONTEST Fri., July 5, 2024 6PM
